Only food purveyors such as restaurants, caterers, bakeries or other fresh food purveyors are eligible for BrunSCO Bites. By participating in BrunSCO Bites you agree to offer a minimum of three hundred (300) - 3 oz. tasting size portions of a food product you serve. Each additional food product you serve should also be a minimum of three hundred (300) - 3 oz. tasting size portions. Restaurants and Caterers can choose to be a vendor without offering food, but will have to pay a vendor rate and will not be located in the BrunSCO Bites area.
